FDI is governed by a General Assembly. The elected Council initiates, conducts, delegates, monitors, and coordinates all FDI business. Each year, nearly 300 members attend FDI's World Dental Parliament to debate and define the global future of dentistry. FDI headquarters is based in Geneva, Switzerland.

The FDI World Dental Congress is a flagship event, strengthening ties and fostering collaboration within the global oral health community. It is an annual go-to event for dentists and other oral health professionals, chief dental officers, public health officials, and industry representatives. The Congress aligns with FDI's mission to advance and promote the science and practice of dentistry.

Close to 8,000 participants from around the world met in Buenos Aires, Argentina, in September 2018 for the Congress. The theme was *A passion for many, a commitment for all*; the event was organized in cooperation with the Argentinian Dental Association (Confederación Odontológica de la República Argentina) and featured a scientific programme with nearly 130 international experts.



The Congress boasts a diverse scientific programme with oral health experts who present on a wide spectrum of subjects in the dentistry field, from caries management protocols to regenerative endodontics. FDI takes great care in creating a unique and modern scientific programme every year. In 2018, the scientific programme addressed broader public health issues, such as the global rise in sugars consumption, and how they impact the oral health community.

2018: Securing a sustainable future for the FDI World Dental Congress

In 2018, FDI was able to secure FDI World Dental Congress destinations for the next three years: San Francisco, USA, in 2019; Shanghai, China, in 2020; and Sydney, Australia, in 2021.

Say Ahh: Think Mouth, Think Health

World Oral Health Day (WOHD) is a far-reaching global oral health campaign that raises awareness and encourages people to take charge of their oral health. Everyone has the power to reduce the impact of oral diseases on individuals, families, and communities. By working together and coordinating efforts, the public, the oral health community, and policymakers can amplify the importance of good oral health every year. WOHD is celebrated on 20 March and was first launched by FDI in 2007. The WOHD Global Partners are Henry Schein, Philips, and Unilever. The WOHD Global Supporters are Planmeca and the Wrigley Oral Healthcare Program.

The overarching campaign theme for 2018–2020 is ‘Say Ahh’ – a phrase that is commonly used by both dentists and doctors during check-ups and invites patients to open their mouth for examination. Combined with different sub-themes each year, ‘Say Ahh’ means that the mouth serves as a mirror to the body and reflects overall health.

In 2018, the aim of the WOHD campaign was to teach people about the mouth and body connection. ‘Say Ahh: Think Mouth, Think Health’ encouraged people to make the connection between their oral health and general health and well-being. The campaign highlighted links between oral diseases and other diseases, raised awareness of common risk factors, and promoted good oral hygiene habits. The campaign taught people that good oral health keeps the mouth functioning well and helps maintain overall health and quality of life.

Sharing our campaign resources around the globe

The WOHD 2018 messages were shared through a range of resources – all made available in (at least) English, French and Spanish – which were downloaded 21,570 times (vs 18K in 2017) from the WOHD website.

Targeted stakeholder engagement

Three versions of the campaign toolkit with messages tailored to each audience – members, partners, and the general public – were produced. Their purpose was to more effectively engage all stakeholders and help users roll out the campaign at a country level.

In addition, three campaign posters were produced to raise awareness as broadly as possible by leveraging diverse settings and targeting different audiences:





A brochure, *Understanding the mouth and body connection*, was prepared for the general public to help them learn how their oral health affects their general health and show them what they could do to safeguard both.

To ensure governments also played their role in protecting the oral health of their population, FDI produced an advocacy toolkit, *Getting policymakers to Think Mouth, Think Health*. It included a series of recommendations to advocate for oral health in all policies.



Video

The campaign video, in line with the concept from the main ('at home') poster, was shot and directed in-house and released in March 2018. The video was available in English only, but was subtitled in five languages. A version of the video was also adapted for the NASDAQ screen. The video received 441,780 views globally – 134.2K views from FDI social media and 307.5K from NASDAQ.

Tailored advertisements for oral health professionals

FDI collaborated with Dental Tribune International to produce **24 advertisements** specifically targeted to oral health professionals.

From the 24 ads produced, there were 19 different languages featured in 27 DTI editions – giving visibility to 18 participating National Dental Associations (NDAs) who helped with the translations and had their logos included in the ads.

Social media materials

FDI produced a social media guide with tips on how to engage with WOHD and released it in February 2018, along with Facebook and Twitter cover photos. For member NDAs and partners, FDI included a calendar in the member hub with pre-made posts and accompanying visuals so that they could share them on their own social media platforms. FDI then implemented this simultaneously across all of its social media platforms.

WOHD was promoted across Facebook, Twitter, LinkedIn, YouTube, and – for the first time – Instagram. The official campaign hashtags were #WOHD18 and #SayAhh.

TEACHING CHILDREN TO THINK MOUTH THINK HEALTH

On World Oral Health Day, FDI World Dental Federation carried out a global survey about children's oral health.

PARENTS OF CHILDREN AGED 18 AND UNDER FROM 10 COUNTRIES

Only 13% of parents took their child to the dentist before their first birthday

26% ONLY of parents said they personally cleaned their child's teeth from as soon as the first tooth pushed out

Poster Customization App

The popular Poster Customization App, which allows users to customize their own posters, was redesigned in line with the *Say Ahh: Think Mouth, Think Health* messages, included a call to action to empower people. The app was promoted across social media in February 2018 and had **2,207 poster customizations** (vs 2.1K in 2017).

Brush Day & Night

Brushing twice a day with a fluoride toothpaste is one of the most important habits for good oral health. Through Brush Day & Night (BDN) activities, children learn about the benefits of good oral hygiene and are taught to brush their teeth twice-daily with a fluoride toothpaste. BDN also encourages children to become community advocates and spread the message of good oral health to their families and friends. BDN activities are made possible through a long-standing partnership between FDI and Unilever.

Phase III supplement published in the International Dental Journal

During Phase III, BDN coordinated oral health outreach activities in schools and conducted World Oral Health Day (WOHD) celebrations, reaching over 4 million individuals. A detailed evaluation of Phase III was published in a supplement to FDI's *International Dental Journal* (IDJ), which was released during the first quarter of 2018.

A brochure illustrating key facts about the methodology of the programme and the positive results of Phase III was released in November 2018. The brochure synthesized the content of the IDJ supplement and included an infographic to appeal to a wider audience and make the findings as accessible as possible.

Phase IV: improve existing methodology, impact and outcomes; set additional objectives

Phase IV, which will run until the end of 2019, is currently being implemented at the national level through:

- ▶ flagship school programmes on oral health in Indonesia and Nigeria;
- ▶ WOHD activities in 11 countries: Bangladesh, Chile, Egypt, Ethiopia, Ghana, Indonesia, Ivory Coast, Kenya, Nigeria, Sri Lanka, and Vietnam. In 2018, WOHD activities in these countries reached over 2.1 million people.

Phase IV is focused on strengthening the BDN methodology and sustaining the programme for schoolchildren aged 6–9 years, as Phase III results showed that it was most effective for this age group. Phase IV also seeks to monitor and measure how increased oral health knowledge among children impacts their quality of life; it also aims to evaluate how their oral health knowledge impacts the oral health habits of their parents/caregivers.

CPP Phase II engages dental practitioners through interactive webinars

Two webinars were held in 2018:

- ▶ **Working together to enhance patients' self-care** with Prof. Tim Newton
- ▶ **Sugars and oral health: evidence to practice** with Prof. Paula Moynihan

The Caries Prevention Partnership (CPP) is an international effort to reduce the burden of dental caries by shifting the focus of dental care from a restorative to a preventive approach. Untreated dental caries is the most prevalent chronic disease worldwide and a major global health problem. CPP develops high-quality caries educational material, develops advocacy strategies, and designs activities destined for the public, oral health professionals, and policymakers. This project is supported by Colgate.

FDI Smile Award: winners plan oral health check-ups and promote limits on sugary drinks in schools

The FDI Smile Award (US\$5,000) supports FDI member National Dental Associations (NDAs) that are making a difference in oral health through innovative and sustainable community outreach projects in their countries.

INDIA AND NEW ZEALAND RECEIVE FDI SMILE AWARD IN 2018

The Indian Dental Association's National Oral Health Programme strives to attain optimal oral health for all by 2020, notably through oral health check-ups and awareness-raising camps for children.

The New Zealand Dental Association is supporting New Zealand schools to become "water-only", which means that water and low-fat milk would be the only drinks permitted on school premises.

Oral health professionals offer feedback through the CPP Survey

FDI designed a survey for oral health professionals to evaluate the CPP Chairside Guide. The online survey was conducted between April and June 2018, with tailored questions for member NDAs, FDI experts, and the wider FDI network. The feedback was generally positive: 77% of respondents agreed that the guide was informative and useful. The majority of respondents (73%) agreed that it helped them adopt a preventive approach based on age and that it supported their decision-making about caries management.

Global Periodontal Health Project

The Global Periodontal Health Project (GPHP) aims to reduce and prevent periodontal disease worldwide. Periodontal disease is a major cause of tooth loss in adults. It begins as gingivitis, which can be easily treated if action is taken early. If left untreated, gingivitis can progress to periodontitis, a more serious infection that destroys tooth-supporting tissues and bone. Launched in partnership with E.M.S. Electro Medical Systems, GSK, and Procter & Gamble, GPHP engages the public, oral health and other health professionals, educators, and policymakers in promoting periodontal health.

GPHP Chairside Guide: a practical reference guide on periodontal diseases

In 2018, the project developed the Periodontal Diseases Chairside Guide. The guide was developed in line with an overarching goal of the project to offer concise and comprehensive information on periodontal diseases to oral health professionals.

FDI establishes an official position on periodontal diseases with GPHP

Policy Statement

An FDI Policy Statement was presented at the FDI World Dental Congress in Buenos Aires and received 95.6% approval from FDI members. It addresses the global burden and socio-economic impact of periodontal diseases and identifies the major challenges in tackling the problem.

Over 300 participants attend GPHP Symposium on periodontal health

Entitled *Proactive prevention and effective periodontal care*, the GPHP symposium highlighted the major challenges in achieving periodontal health and preventing periodontal diseases. It included a scientific update on the new classification of periodontal diseases and effective patient management solutions.

Oral Health for an Ageing Population

The Oral Health for an Ageing Population (OHAP) project ensures that oral health challenges are addressed in broader health policies for ageing populations. Older people are often at an increased risk for tooth loss, periodontal disease, oral cancer, and other illnesses. By focusing on the importance of oral health in ageing populations, the oral health community can play an essential role in ensuring that people age in a healthy and supported way. OHAP is supported by GC International.

Advocating a life-course approach to oral health

According to the World Health Organization, the life-course approach to health focuses on a healthy start to life and **targets the needs of people at critical periods throughout their lifetime**. The same approach can be applied specifically to oral health. Elderly people have specific oral health needs that require targeted dental interventions.

To promote the life-course approach to oral health for ageing populations, OHAP released two key publications, the *Roadmap for Healthy Ageing* and *Achieving a Healthy Ageing Society*.

The *Roadmap for Healthy Ageing* is a quick reference guide that provides a range of strategies and actions that different stakeholders can implement to meet the oral health needs of older adults.

Achieving a Healthy Ageing Society illustrates how important it is to adapt health systems and meet the emerging and increasing oral health needs of ageing populations.

The publications were officially released during the 2018 World Oral Health Forum (WOHF), during the FDI World Dental Congress. The forum was an opportunity to discuss how the publications could be used to promote the close relationship between oral health and healthy ageing.

Special virtual issue of the International Dental Journal on oral health for older adults

This virtual issue includes a selection of papers that address concerns linked to oral healthcare for older adults and illustrates the unique challenges associated with providing this care. Topics include disparities in dental insurance coverage for older adults, the level of awareness of oral cancer among older adults, and the general health of elderly patients seen in the dental office, among others.

Peri-implant Diseases Project

The Peri-implant Diseases Project (PIDP) was launched in 2017 to increase global awareness about peri-implant diseases, raise periodontal health as a priority at the national level, and integrate oral health and periodontal health into general health policies. PIDP designs resources for oral health professionals to support the diagnosis, treatment, and prevention of peri-implant diseases. In 2018, PIDP was supported by the International Congress of Implantologists.

Just like natural teeth, dental implants are also susceptible to disease if not properly cared for. Peri-implant diseases, like periodontal diseases, have serious consequences for those affected, including problems with chewing and speaking, leading to negative impacts on well-being and quality of life. It is important to increase the visibility of peri-implant diseases as a key public health challenge.

PIDP Workshop: experts work together to produce practical guidance on peri-implant diseases

A two-day workshop was held in May 2018 in Zurich, Switzerland. The 30 participants drafted the content of four recommendation articles on peri-implant diseases (a consensus of 16 articles drafted in 2017). These four articles will be published together in an *International Dental Journal* supplement in 2019.

PIDP Symposium attended by 300 participants


During the FDI World Dental Congress, PIDP experts Prof. Jörg Meyle, Prof. Stefan Renvert, and Dr Philip Keeve presented on:

- ▶ identification of at-risk patients and selection of candidates for oral implants;
- ▶ selection of an implant, proper placement and restoration to limit risk of peri-implant diseases;
- ▶ diagnosis, prevention and non-surgical management of peri-implant diseases;
- ▶ surgical treatment of peri-implantitis.

Oral Health Observatory

The Oral Health Observatory (OHO) is a research and advocacy project developed by FDI to support member National Dental Associations (NDAs) in collecting data about oral health in their countries. Analysis of the collected data will provide the basis for resources to support FDI, NDAs, and other interested stakeholders in their work to promote better policies for oral health and the dental profession. It will also provide participating dentists with insights into their daily practice.

Dentists and their patients submit data about the patients' oral health status, quality of life, health behaviours, and other health determinants and moderating factors by answering a series of questions via a mobile app. An additional online questionnaire collects data about the participating dental practices.

The programme was developed in 2014 by FDI, and a pilot project in three countries tested the feasibility of using a mobile app to collect data in the dental practice. Following this successful pilot phase, OHO entered Phase II with support from GSK.

A strong Phase II roll-out

OHO Phase II has 12 participating NDAs:

- ▶ Associazione Nazionale Dentisti Italiani/Bundeszahnärztekammer (BZAEK)
- ▶ Chinese Stomatological Association
- ▶ Colegio de Cirujanos Dentistas de Costa Rica
- ▶ Federación Odontológica Colombiana
- ▶ Indian Dental Association
- ▶ Italian National Dental Association
- ▶ Japan Dental Association
- ▶ Kenya Dental Association
- ▶ Lebanese Dental Association
- ▶ Polish Dental Society
- ▶ South African Dental Association
- ▶ Tanzania Dental Association

As of 31 December 2018, OHO collected 3,888 paired patient-dentist responses and 120 dental practice questionnaire responses. This phase will ultimately collect data for over 21,000 patients and 420 dental practices across the 12 countries.

Access to adequate oral healthcare remains uneven throughout the world. Many children, especially from low-and middle-income countries, suffer from untreated tooth decay.

Smile Around the World is an initiative to deliver oral health education and prevention programmes in resource-limited settings in partnership with member National Dental Associations (NDAs).

In 2018, the project was implemented in China by the Chinese Stomatological Association and 3M Oral Care with the following objectives:

- ▶ To increase oral health knowledge and skills of 3,000 schoolchildren.
- ▶ To help teachers and oral health professionals teach oral health prevention in schools.

FDI reports success in China

The programme included 3,614 children and 90 teachers in five elementary schools and one kindergarten in the provinces of Ningxia, Yunnan, and Shaanxi: 1,114 children in Ningxia, 1,500 children in Yunnan and 1,000 children in Shaanxi. In total, 115 dentists and dental students volunteered to support the project.

The project provided oral health education materials including posters, colouring books, oral health education videos, guidelines for dentists and teachers, and coloured pens for the children:

- ▶ 35 posters and 3,020 booklets were available in classrooms and on school bulletin boards.
- ▶ 320 copies of guidelines for oral health professionals and teachers were provided.
- ▶ 3,000 coloured pen boxes were provided to children to use with the colouring books.

World Dental Development Fund

FDI is committed to promoting optimal oral health and general health for everyone, especially in contexts where access to healthcare is limited. The aim of the World Dental Development Fund (WDDF) is to fund oral health initiatives with a strong focus on education and prevention. The fund supports projects that have a positive impact on oral health in resource-limited settings.

FDI supports five innovative projects in 2018

In 2018, WDDF supported five projects in Benin, Nepal, Tanzania, Uganda and Zimbabwe.

In addition, two projects, one from Costa Rica and the other from Kenya, were selected for WDDF funding in September 2018. Both projects will start in 2019. The Costa Rican project focuses on protecting the oral health of a vulnerable indigenous population, and the Kenyan project focuses on ensuring good oral health for mothers and their infants.

All WDDF projects reflect FDI's core values and principles.

Dental Ethics Manual *2nd edition*

Due to their profession and position of trust within society, dentists and other health professionals are given certain privileges that are not extended to the public. As such, health professionals pledge to abide by a strict set of ethical standards of conduct. In 2018, FDI released a second edition of the *Dental Ethics Manual*.

An updated, practical reference for dentists

The new *Dental Ethics Manual* provides examples of specific ethical dilemmas that dental practitioners may be confronted with in the workplace. Its use of practical case studies makes it particularly well-suited to dental students. FDI hopes the second edition will better prepare dental practitioners to grapple with certain ethical dilemmas and uphold an exceptional standard of care throughout their careers.

Endodontics in General Practice Project

The Endodontics in General Practice project was launched in 2018 to highlight the importance of endodontics in daily dental practice and guide general dentists on the provision of optimal endodontic care. The project develops resources to identify challenges and improve the provision of endodontic care. The project proposes calls to action for policymakers and advocates improved systems for endodontic care. The project is supported by Dentsply Sirona.

White Paper on Endodontic Care: promoting a patient-centred treatment plan

In 2018, FDI expert authors drafted a white paper outlining the main issues currently affecting the provision of endodontic care, offering a reference for dentists, NDAs, and other oral health actors. The paper was published in March 2019.

Oral Cancer Project

The Oral Cancer Project aims to improve oral cancer survival rates and quality of life for patients diagnosed with oral cancer by building a wealth of resources that promote oral cancer prevention strategies, advocate early detection, and encourage immediate and appropriate treatment. The Oral Cancer Project is supported by Sunstar.

A proactive approach to oral cancer detection and treatment

The project published *Oral Cancer: Prevention and patient management*, which includes a fold-out chairside guide for clinical examination, as well as a leaflet with a detailed definition of oral cancer, associated risk factors, prevention strategies, and best practices for patient management.

Both elements are designed to be used daily in dental practices and encourage timely referral to multi-disciplinary treatments before, during, and after oral cancer treatment. The chairside guide and leaflet are available in English, French, Spanish, Chinese, Italian, and Japanese.

Sports Dentistry Project

FDI launched the Sports Dentistry Project to reinforce the link between dentistry and sports medicine. Good oral health helps ensure strong athletic performance for both amateur and elite athletes.

In 2018, the project began to develop resources for international sports federations, advocating and promoting the importance of good oral health for people practicing sports. In 2019, the project will publish an advocacy toolkit for sports federations and a series of practical guides for amateur and elite athletes, as well as for dentists and sports medicine physicians. The guides are meant to reinforce the importance of maintaining good oral health for optimal athletic performance.

Partially Dentate Patients Project

Rates of natural tooth retention are increasing globally: rather than losing all their teeth as they age, patients are increasingly greeting old age with at least a few of their natural teeth still intact. This has led to a significant increase in the number of partially dentate patients. This relatively new patient group requires a tailored, comprehensive approach to treatment and care.

The Partially Dentate Patients (PDP) Project was launched in 2018. Caring for a partially dentate patient is a long-term process that includes three main pillars: a pre-treatment/assessment phase, a treatment phase, and a post-treatment/long-term care phase. The PDP Project encourages dentists to place equal importance on each of these three phases and to organize their treatment and care plan along this continuum. The PDP Project is supported by GSK.



What is oral health?

Oral health is multi-faceted and includes the ability to speak, smile, smell, taste, touch, chew, swallow and convey a range of emotions through facial expressions with confidence and without pain, discomfort and disease of the craniofacial complex.

Unified action on oral health


The year 2018 was a year of growth and momentum for FDI’s advocacy activities. After finalizing the ambitious advocacy strategy for 2018–2020, FDI launched its first-ever quarterly advocacy newsletter, made progress in developing a set of adult oral health measures, and intensified efforts to address antimicrobial resistance (AMR). It also represented the oral health community at a number of important global health meetings, including the 2nd Conference of the Parties to the Minamata Convention (COP2) and the third United Nations High-level Meeting on Noncommunicable Diseases (UN HLM on NCDs).

- ▶ **In 2018, GSK joined the Vision 2020 partners: GC, Henry Schein, Ivoclar Vivadent, Morita, 3M, Unilever, and Wrigley.**

A new plan of action to improve oral health

Launched in January 2018, the FDI advocacy strategy for 2018–2020 establishes a platform for oral health action over three years. It provides an overview of oral health successes, challenges, and opportunities and outlines the priorities that FDI will pursue to improve oral health.

FDI’s advocacy work is guided by three goals:



Advocacy newsletter: updates and opportunities for FDI members and Vision 2020 partners

To keep FDI members, partners, and networks informed and prepared for action, FDI launched a new quarterly newsletter in 2018 – the FDI Advocacy Update. The newsletter covers the latest developments in the global health and development agenda and FDI advocacy activities, as well as what’s happening next, opportunities to get involved, key events, and resources.

Oral health measurement tool: monitoring change in oral health status across all populations

To advance FDI’s goal to develop baselines and indicators to measure oral health outcomes globally, the FDI-International Consortium for Health Outcomes Measurement Working Group finalized the Adult Oral Health Standard Set of Measures (AOHSS) and started to prepare the accompanying manuscript. The AOHSS and manuscript is expected to be released in 2019.

Road to the UN High-level Meeting on NCDs

WHO Civil Society Working Group

FDI joined the WHO Civil Society Working Group for the HLM on NCDs to advise the WHO Director-General Dr Tedros Adhanom Ghebreyesus on bold and practical recommendations on mobilizing civil society ahead of the HLM.

WHO Independent High-Level Commission Report: Time to Deliver

FDI provided feedback on the draft WHO *Time to Deliver* report outlining recommendations to reduce the NCD burden and successfully secured oral health perspectives within the final report.

Draft Political Declaration on NCDs

FDI shared a template letter to its members ahead of the HLM. The letter, developed together with the International Association for Dental Research (IADR), outlined key recommendations and amendments to the draft declaration for the HLM.

UN multi-stakeholder hearing

FDI submitted two statements at the UN multi-stakeholder hearing in New York in the lead up to the HLM pushing for renewed political commitments for the prevention and control of oral diseases.

HLM Political Declaration on NCDs

In response to the weak political declaration adopted by Member States at the HLM on 27 September in New York, FDI released a statement criticizing the missed opportunity by countries to take targeted action on oral diseases and other NCDs.

Shifting the focus to oral health on the global health agenda

World Health Organization Executive Board and World Health Assembly

At both the 142nd WHO Executive Board in January and the 71st World Health Assembly in May, FDI delivered statements on three topics: maternal, infant and young child nutrition; preparation for the third UN HLM on NCDs; and mobile health (mHealth).

Dental amalgam

WHO African Regional Workshop on the Minamata Convention

FDI participated in the WHO African Regional Workshop on the Minamata Convention in April 2018 in Johannesburg, South Africa. The invite-only workshop included WHO African Regional Member States, UN Environment Programme, FDI, International Association for Dental Research (IADR) and International Dental Manufacturers. The meeting served as an important opportunity for FDI to be profiled to African ministries as one of the leading organizations that WHO works with on the phase-down of dental amalgam.

COP 2: Minamata Convention on Mercury

Around 150 countries and many other stakeholders, including FDI, participated at COP2 from 19–23 November in Geneva, Switzerland. After much back and forth throughout the meeting, COP2 delegates agreed to postpone discussions on the review of Annex A of the Convention, which contains dental amalgam phase-down provisions, to the third COP meeting in 2019. In the lead up to COP3, FDI will continue to work with its members to advocate for the phase-down, not phase-out, of dental amalgam.

FDI fully supports the phase-down of dental amalgam, but countries and dentists must be given access to safe, effective and affordable alternatives. This will not become a reality in many countries, particularly in low- and middle-income countries, without sustainable funding and increased prevention and research into alternative treatment options.

Antimicrobial resistance

WHO expert consultation group on AMR

FDI plays an active role in WHO's expert consultation group on health workforce education and AMR, which published the *WHO Competency Framework for Health Workers' Education and Training on AMR* in June 2018. The published framework is designed to be used as a reference guide and aims to ensure that all health workers, including dentists, can address AMR in policy and practice settings.

FDI attends second annual global meeting to accelerate action on AMR

FDI participated in the second annual 'Call to Action' on AMR in Accra, Ghana, from 19–20 November. As dentists prescribe up to 10% of all antibiotics used worldwide, they are implicated in the fight against AMR, together with other health professionals. The meeting discussed the most critical gaps in tackling the development and spread of drug-resistant infections. It brought together health officials and AMR stakeholders to focus on a global coordinated action to prevent and stop the rise of superbugs.

Engaging in strategic partnerships

FDI's strategic partners help FDI drive its advocacy work forward and effectively influence the global health and development agenda.

FDI-NCD Alliance-WHO joint session on sugars consumption

In September at the FDI World Dental Congress, FDI hosted a joint session with the NCD Alliance and WHO, *Curbing the Sugar Rush: Tackling oral diseases and other NCDs through a unified approach*. Presentations focused on how decreasing sugars intake through preventive interventions is a major strategy that can contribute to reducing the risk of developing oral diseases and other NCDs.

First-ever FDI-NCD Alliance webinar

In November, FDI hosted a joint webinar with the NCD Alliance. The webinar, *Oral Health & NCDs: How to collaborate and find common ground for better health outcomes*, explored how the oral health and broader NCD community can accomplish their common goals by working together. It highlighted opportunities for action with case studies from the New Zealand Dental Association and the Sweet Enough Network in Thailand.

FDI contributes to four World Health Professions Alliance statements at the WHO Executive Board and World Health Assembly

FDI united with its partners in the World Health Professions Alliance (WHPA) to make four statements at the EB142 and WHA71. The statements focused on: mHealth, WHO's draft 13th general programme of work 2019–2023; public health preparedness and response; and health, environment and climate change.

The fifth World Health Professions Regulation Conference (WHPRC): Facing challenges to acting in the public interest

A group of 153 participants from 36 countries gathered for WHPA's fifth WHPRC in May 2018 to explore the insights, perspectives, and discussion on current challenges in health professional regulation. Widespread reform of health professional regulation reflects policy initiatives by many governments to ensure sustainable, efficient, and effective health service delivery.

Mid-year Meeting

The 2018 Mid-year Meeting was held in Iowa City/Coralville, USA, in May 2018. During the meeting, Council and the Committees aligned their activities with the new FDI Strategic Plan. During the meeting, FDI staff provided updates on FDI's advocacy and communications strategies and reported on progress made on all FDI projects, partnerships, and the FDI World Dental Congress planning process. Committees, Task Teams, and the Continuing Education Programme shared their reports as well.

General Assembly

As FDI's foremost legislative and governing body, the General Assembly sets FDI policies, defines the strategy, and monitors the implementation of FDI's mission.

Demonstrating global consensus on key oral health issues

The General Assembly adopted 10 new FDI Policy Statements, which detail FDI's position on issues of interest within the oral health community. They are put together through consultation, discussion, and consensus among leading dental experts from around the world.


The Travel Grant facilitates an inclusive FDI World Dental Congress

Eligible NDA members may apply for a travel grant in order to attend the FDI World Dental Congress and have up to 60% of their travel expenses covered by FDI. The travel grant is available to NDA members from low-and low-middle income countries who would like to attend the FDI World Dental Parliament Business Meetings and General Assembly at the Congress and be part of the FDI decision-making process.






History of income, operating expenditure, and result of the year
